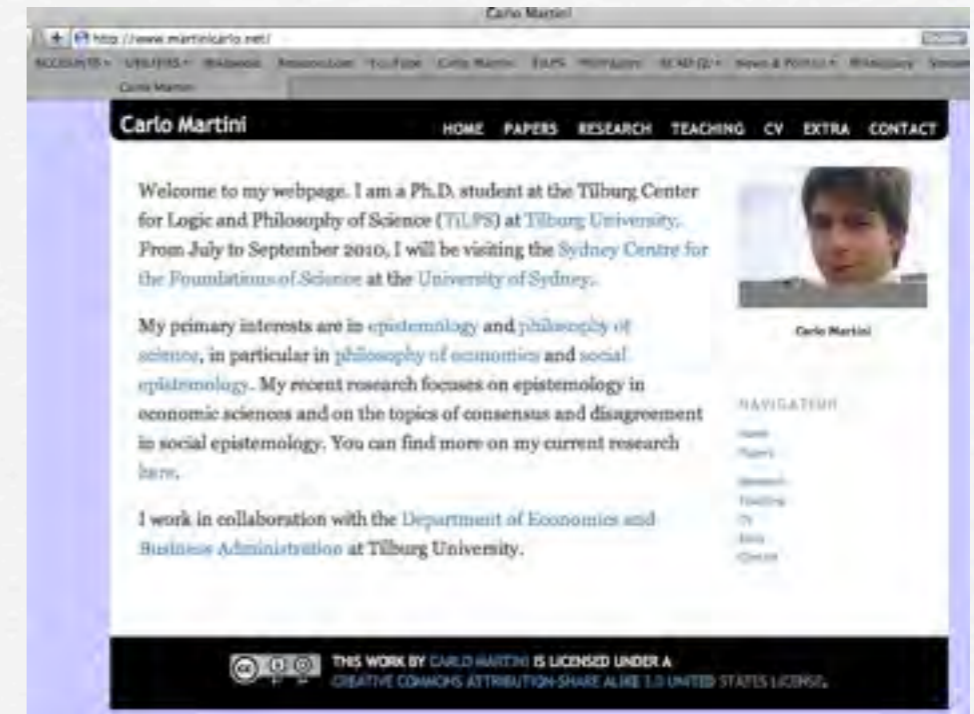

Adam Smith (1723 - 1790)

GOALS OF THIS COURSE:

- Understand what type of economy and political economy Smith is defending.
- Understand Smith's arguments and assess them in the light of later economic research.
- Understand what the meaning of 'free market' is, in the interpretation that Smith and other "Smithians".
- *Make Smith talk (see Wight).*

MAIN CONTRIBUTIONS:

- *The Theory of Moral Sentiments* (1759)
- *An Inquiry into the Nature and Causes of the Wealth of Nations* (1776)



QUESTION: How do the two works relate to each other? see Fleischacker (2004): tension between Smith's moral philosophy and his political economy.

Adam Smith

...the more general question (see Fleischacker):

- *what are, if there are any, the philosophical contributions of the Wealth of Nations?*



Some questions from the readings:

- What is the point of making Smith *talk*?
- What are character-Smith's complaints?

“Can we go back to your point, something about wick and wax?” I asked “What have economists missed about society?”

He raised his finger for emphasis: “the vital interplay betwixt human beings that makes it a society, the ‘fellow-feeling’ that is the foundation for moral conduct.”

Jonathan Wight, *Saving Adam Smith*

By putting those words in Smith's mouth, Wight seems to imply that in the *Wealth of Nations* there are, in fact, moral concerns.
